It was RESOLVED that the minutes of the Parish Council Meetings held on the 5<sup>th</sup> of September and 21<sup>st</sup> November 2022 were taken as read and confirmed as a correct record and signed by the Chairman.

  - 5.2 Late Payment Request/s to be discussed for approval and payment. It was RESOLVED to purchase at a cost of £70 a case for the Scout 2 Speed Recorder. It was RESOLVED that the Scout 2 Speed Recorder and case would remain the property of the parish council and would be added to the asset register.

    - 5.5.1 To review the 2022/23 spend vs budget forecast. It was noted that due to the increased costs of maintenance, administration, the purchase of a new bench and speed watch equipment the budget would be over spent by the year end.
    - 5.5.2 To agree the budget for 2023/24. It was RESOLVED that the budget was set as £27,870

      It was RESOLVED that the precept would be set at £15,430 representing a Band D of £49.92 per annum and an increase of £4.54 per Band D property per annum.

7.1 Byways Cllr Barrier

- 7.1.1 KCC PROW Alkham Byways Clearance Volunteer Day 27<sup>th</sup> January 2023. It was reported that KCC Had contacted the parish council to assist in the booking of the Village Hall for the Volunteer Day. KCC had been informed by the VHMC that they had to pay cash in advance. This was not possible. It was RESOLVED that the parish council would pay the invoice on behalf of KCC and reclaim it.
- 7.1.2 Cllr Barrier reported that fallen trees were blocking the PROW near Short Lane. Concerns were Raised regarding the condition of Pimlico PROW. It was AGREED that Cllr Barrier would contact KCC PROW regarding this

The amendments made by the parish council to the draft Community Plan were accepted by the Community Plan Group. It was RESOLVED that the Parish Council would accept the amended plan. It was RESOLVED that the Clerk would identify an editor to check layout, spelling and grammar.

7.3 Drainage and Flood Warden Report

Cllr Hibbert reported that: the latest work updates for submitted Alkham drainage fault reports to Kent Highways drainage department were as follows:

- 666264 Martin Vale, Hogbrook Lane enquiry under investigation.
- 642292- Village Sump, job completed.
- 652656 Alkham Ditch, Valley Cottages. Request to clear out whole length of ditch. This section falls within the responsibility of KCC under an agreed contract. Work programmed.

The Village Green swale. To discuss for annual clearing funding from APC.

Village Green Ditch – compaction of leaves in ditch causing downstream blockages in Short Lane culverts and local flooding risk. Discuss need for petrol blower to regularly remove debris from ditch in autumn period to mitigate this risk. Work to be undertaken by volunteer riparian owners. Blower to be held by KCC Flood Warden. It was AGREED that a leaf blower would not be purchased at this time.

8.1 Highways Improvement Plan (HIP)

Cllr Hibbert gave an update on the meeting held with KCC Highways and reported on the items that were agreed to. It was RESOLVED to accept the HIP and that the Clerk would post on the website.
