9. Dover District Council Report

District Councillor Nick Dixon reported that District Council have been liaising with Canterbury, Shepway, Thanet and Ashford Council to form one single Council. It was reported that Ashford had a few months ago decided not to be involved and that Shepway had also voted against. Dover District Council are therefore now assessing viability of a single Council made up of Dover, Canterbury & Thanet. The idea is to enable funding to continue into the local communities.

It was also reported that the variable speed limit on the A20 will come into effect in summer 2017. There had been a delay due to the environmental groups complaining about the gantry signs that will display the variable speed limits.

It was noted that the works at Russell Gardens are now almost complete with improvements made to the road and pedestrian layouts. There is also substantial work planned for Kearsney Abbey too.

The Port of Dover has awarded the contracts for the marine engineering works and the project is moving forward quickly. It is anticipated that Stage 1 (new piers, marina and the Cargo terminal) will be completed by the end of 2018. The St James development is also well on the way now, the shells for the multiplex cinema and the Travelodge are already up. It was reported that Enterprise, car and van hire will refurbish the current BP garage. It was noted there will continue to be disruption in and around Dover associated with the works at the Western Docks whilst works continue.

It was noted that traffic though the villages will be an ongoing issue all the time the variable speed limit is in place on the A20.

Cllr Burrows asked if the white lines will be replaced at Russell Gardens and it was confirmed that this would happen very soon.
