# Alkham Drainage Work Progress Updates – November 2021

Latest work updates for submitted Alkham drainage fault reports to Kent Highways drainage department are as follows:

- ▶ 596053- Roadside drain adjacent Martin Vale, Hogbrook Hill blocked work scheduled.
  - The double culvert underground pipes, linking the Garden Centre ditch to the ditch outside the entrance to the Meadows CV site remain blocked. I attended the site with Ian Day again late September for a further inspection. Work now scheduled to clear vegetation in the ditch east of the entrance driveway to allow culvert investigation and jetting out to clear any culvert blockage. If not, successful camera inspection will be the next step forward.
  - KCC drainage team have cleared out silt from roadway culvert adjacent Thorn Cottage. This a continuing problem following heavy rainfall with backwash silt from Meggett Lane flowing down to this central location. KCC can only advise constant portal reporting via their website requesting attendance and clearance.
  - Ditch east of Short Lane roadway culverts cleared out by landowner. Unfortunately, established ditch filled in up to the new boundary fence. Small runoff sump left east of roadway culverts. Local concerns raised that the changes would result in possible local flooding to properties at the bottom of Short Lane. Concerns reported back to KCC Drainage team via portal and Alkham Flood Warden.
  - Alkham Flood Warden met with Emma Burdett, KCC Drainage Engineer on 22<sup>nd</sup> Oct to inspect infilled ditch at Short Lane. Also, to inspect ditch at Valley Cottages and a riparian ownership section east of that location. Resultant actions by KCC are to chase for re-establishment of infilled Short Lane ditch via landowner, write to riparian owner to clear deposited tree foliage from ditch, and Valley Cottage section of ditch between box bridges to be cleared completely, both sides of the banks (this work re-established as continuous KCC responsibility).
