Appendix A

Alkham Drainage Work Progress Updates – March 2019

Latest work updates for submitted Alkham drainage fault reports to Kent Highways drainage department are as follows:

- ➤ 376176 Hogbrook sump last advised that an outside contractor job has now been assigned. Area identified for temporary deposit of silt on section of car park. Area will be cordon off and signed. Work to commence within 90 days (from 18/02/2019).
- ➤ 379509 Wolverton Hill three blocked drains, enquiry still under investigation. Work now being programmed.
- ➤ 385302 Short Lane-culvert headwalls still awaiting repair and removal of old sandbags that have become a potential hazard. Area inspected and under further investigation. Work uncompleted.
- ➤ 373611 Meggett Lane road culvert and silt trap. Work being programmed to clear down to ditch levels following riparian work.
- ➤ 412439 Little Everden Road section of road 100yards west of Pimlico Boat exit regularly flooding due to old grips blocked by concrete bags. Flood water contaminated by fuel and risk of AV aquifer water supplies. Photos (provided courtesy of parishioner) and report sent direct to KCC Highways Ian Day for action.
- ➤ Updates regarding Highways riparian ownership/responsibilities for ditch along the Alkham Valley Road. Still awaiting feedback information.
- ✓ On 18/02/2019, Village Green site inspection with Annie Thurgarland, KCC Natural Flood Management, KKC surveyors and nominated Contractor. To prepare reports and work programme to construct a new swale on west side of VG to take flood water off Hogbrook Hill Road and direct into ditch end of sump. Work scheduled to take place 4-6 weeks time. Work funded by KCC Highways.
- ✓ During February, Flood Warden gave Ian Day (KCC Drainage and Structures Assistant Engineer) an inspection tour of outstanding Alkham flood and drainage fault issues.
