Alkham Drainage Work Progress Updates – December 2020

Latest work updates for submitted Alkham drainage fault reports to Kent Highways drainage department are as follows:

- 459519- Hogbrook Hill, drain and culvert adjacent Martin Vale blocked with silt, work completed. This drain consistently gets blocked by leaves and debris and I have personally cleaned the top grid on a regular basis.
 - 459824- Meggett Lane water off Alkham Valley Road missing drain located adjacent to St Cedric due to road camber. Water flooding bottom of lane with no drainage grip in place to ditch. Job attended 27/10, but more work required to resolve problem.
 - Appeal to residents with drains adjacent to their properties to 'adopt a drain'. During the periods with rain, have a quick check and if covered with loose debris sweep off. This will help tremendously and help stop flash flooding during heavy rain and thunderstorms.
 - Good news following networking with Emma Burdett, KCC Land Drainage Engineer, and Ian Day, KCC Highways Drainage Engineer over the last few weeks. Clearance of the sump and the ditch running alongside the Village Hall is scheduled to take place in December, weather and ground conditions permitting plant work. Rediscovered KCC records show that this work was an agreement made following the floods of 2013/2014 that wherein highways would undertake a clearance on the section of the ditch next to the village hall and the sump area. However, the ditch will only be cleared under a courtesy agreement to help reduce highway flooding and subject to funding no more than once every calendar year, with any necessary further maintenance being the responsibility of the riparian owners – the exception to this would be the culvert running under the highway and the Sump at the outfall, which remains under perennial KCC maintenance for highway safety within the public maintainable area. Any requests for additional clearance in this area to be made via the Flood Warden.
 - Recent reports received regarding flooding just past Everden Cottages and the AVR flood relief pipe by Newlyn's (complete with photos) have been forwarded to Ian Day, KCC Land Drainage Engineer, who has confirmed that he passed the enquiry on to his support engineer for investigation. Thanks to Glyn and other residents who help me with my job, it is much appreciated, and helps to keep the community safe.
 - Finally, in Oct, I attended flood warden training, hosted by the Environment Agency via Zoom, in conjunction with the Kent Resilience Team. I am now registered as the KCC flood warded for Alkham area. This will not substantially change what duties I currently personally undertake, but I will now be directly informed on any bad weather and flood alerts for the Alkham area. At the same time now officially being the registered first point of contact for flood emergency responders under the overarching Kent prepared emergency scheme.
