## 5. Minutes of the Parish Council Meeting 5<sup>th</sup> November 2018

To consider the minutes and if in order sign as a true record

Cllr Hillier identified two corrections these were amended and signed by the Chairman.

Cllr Beaney proposed that the minutes be accepted as a true account of the meeting and this was seconded by Cllr Hibbert. **Resolved:** Councillors agreed that minutes were an accurate record of the meeting and were signed by Cllr Burrows.

## 7. To approve the 2019-20 budget and precept requirements

The Clerk circulated a draft budget to all members with Precept increase options for 2019/2020. The Clerk explained that for the last two financial years the Parish Council spend was greater than precept. The overspend were taken directly from reserves.

The figures for 2018-19 were complicated by the fact that the precept had been paid in the previous year, giving a perception of greater reserves. 2017-18 there was an overspend of £3,360. The current year 2018-19 estimated overspend would be in excess of £4,000. The budget figures for 2019-20 indicated that the overspend will be approx. £3,436. The Clerk explained that the precept could only be calculated using the 2018/19 tax base as the 2019/20 tax base had not yet been received from DDC.

The Parish Council discussed the reduction in reserves, which at year end 2019 are anticipated to be approx. £48,000. However, much of this is ring fenced for specific projects to improve matters for the village, including the community plan, traffic action group and the upkeep of village assets.

The Parish Council agreed to take measures to prevent further depletion of reserves. It was agreed that grants and external funding will be sought for projects before reserves are spent. Savings have been made where possible, with many budget items reduced by a small % to try and limit the increase in Precept for 2019/20, without having a dramatic impact on village services. However, it was agreed that the all the traditional items of general maintenance and administration associated with the parish – salaries, the ongoing costs of running the open spaces, contested elections etc., should be met from the precept.

After lengthy discussion it was agreed to raise the parish precept from £8,142 to £12,500 for 2019-20. Proposed by Cllr Hibbert and seconded by Cllr Barrier

## and agreed by all. Resolved: The Parish Council will increase the precept for 2019/20 to £12,500 a percentage increase of 53.52%

The Council Tax is based on a statutory calculation of the number of chargeable households in the parish and is used to calculate the Council Tax for the year. Utilizing the 2018/19 tax base for Alkham which is 307.61 for Band D equivalent properties.

The increase in the Alkham precept proposed for 2019/20 is £ 4,358 which when divided by the Tax Base of 307.61 Band D equivalent houses within the parish, results in Parish Council Tax figure of £ 40.64 for the year. This equates to an increase of £14.17 on last year's figure of £26.47. This is a weekly increase of 27p. The Alkham Parish Council Precept is now £40.64 per annum which equates to £0.78 per week per Band D equivalent house.

The Parish Council are always reluctant to increase the Precept but hopes that residents will feel that the increase will be beneficial. Alkham continues, deservedly, to be a very popular parish, because of its vibrant community and excellent facilities. The Parish Council is seeking to do everything in its power to make sure the Alkham Parish continues to be a good place for everyone to live.

## 8. Public Participation and Comment

Meetings of the Parish Council are not public meetings, but members of the public have a statutory right to attend meetings of the council as observers. They have no legal right to speak unless the Parish Council Chairman authorises them to do so. Members of the public may not take part in the Parish Council meeting itself.
